IV. Oral Reports

a. Achievement

Jana Somma and members of the Achievement Team present benchmark baseline data, a Winter Keystone Exam update, AP Exam Data, and the PVAAS Growth Report.

b. Enrollment and Attendance

Angela Villani states current enrollment is 1,495 students. Average daily attendance is 92%.

c. Discipline

Andrew Boglioli reports that during virtual learning there have been no in school or out of school suspensions. Guidance counselors have been holding social/emotional support meetings during distance learning. 51.5% of students had perfect attendance during the month of October.

d. Diversity

Angela Villani reports that the Diversity Committee has been working to identify a consultant to work with the school. The consultant they found recommends beginning with an all staff climate survey.

e. Budget to Actuals

Angela Villani presents the budget to actuals as of September 2020. General Fund Revenue over expense current - \$1,737,888 under projected budget by \$6,501. The school has 51 days of cash on hand as of 9/30/2020. 60 days required by bond covenant. The health and lease subsidies are due from PDE, IDEA is due from the SDP, and we are expecting federal funds to come in. PSERS is due, and is paid quarterly.
