Introduction

The findings of a recent study showed that there is a significant benefit to students who participate in out-of-school-time (OST) programs. In fact, the <u>Return on Investment of Afterschool Programs in Pennsylvania</u> study determined that for every dollar invested in after- school programming for students there was a return of \$6.69 in potential benefits to students, including reduced rates for drop-outs, teen pregnancy, substance abuse, crime and delinquency (<u>Link to PSAYDN.org</u>).

In accordance with the American Rescue Plan (ARP) Act and Pennsylvania Act 24 of 2021 (Act 24), the Pennsylvania Department of Education (PDE) will award approximately \$50,000,000 or one percent (1%) of Pennsylvania's ARP Elementary and Secondary School Education Relief (ESSER) State Reserve funds to support school districts, charter schools and cyber charter schools (collectively, LEAs) in the development and implementation of comprehensive after-school programs to address learning loss in response to the academic, social, emotional and mental health needs of students and subgroups of students impacted by COVID-19 public health emergency that supplement school programs and activities.

Act 24 requires that, when available, existing personnel shall be utilized by school districts, charter schools and cyber charter schools to staff programs and activities established with these grant funds.

Within 90 days of receipt of these allocations, school districts, charter schools and cyber charter schools must submit a three- part plan to PDE, that outlines the proposed use of the grant money, itemized by program and activity. This plan is part of a consolidated application that includes after-school programming, summer programming, and a comprehensive plan to address learning loss. The plan shall include:

- 1) A description of each program and activity
- 2) A narrative outlining the expected benefit of each program and activity
- 3) A budget for each program and activity detailing personnel and operating costs

In Mariana Bracetti's ESSER II and ARP ESSER applications, funding was allocated for full-time staff members to provide after school programming focused on academic support for the next three years (2021-2024). These offerings are designed utilizing PDE's Integrated System of Support for Accelerated Learning with a focus on high-quality academics to help students successfully master grade level content as well as provide a system of scaffolded supports. However, additional steps must be taken to ensure these after school offerings maintain healthy systems conditions and foster a supportive learning environment in which both students and staff members can mentally and socially recover. Current staffing challenges have made it evident that we cannot rely solely on full-time staff members to provide a comprehensive set of after school offerings. Additionally, current club attendance records show further student interest in the arts, STEM, and robotics. As such, these ARP ESSER setaside funds will be utilized to partner with local organizations to provide these program enhancements in addition to the academic supports already being offered. Further student interest assessments will be completed to determine more specifically which partners will be the best fit in the three areas identified.

Students' academic progress will continue to be monitored through benchmark assessments as well as more regularly through formative and summative assessments. Analysis of these assessments, coupled with student interest, will drive the specific arts, STEM, and robotics offerings provided as well as the key interdisciplinary skills on which they should focus. Programming will be standards-based with particular attention given to areas in need of learning acceleration. These after school program enhancements dually provide additional academic support while also offering productive creative outlets to promote student social emotional wellness.
